**Monday March 8, 2021 at 6:30 p.m. during the Township Board Meeting being held virtually**

The Wayland Township Board will hold a public hearing to consider a request for a Special Use Permit from T & M Partners, LLC. **The request is to renew a Special Use Permit to conduct a mineral mining operation.** This Permit expired in 2017 and a new Permit must be approved by the Township before mineral mining is allowed to resume on the property. The renewal application proposes to close the existing driveways serving the mining operation on 4th Street and is requesting that a new driveway be constructed on 129<sup>th</sup> Avenue to provide access to the site.

This property is located on the south east corner of 129<sup>th</sup> Avenue and 4<sup>th</sup> Street. The parcel number is 03- 24-023-009-00.

If in-person public meetings become a lawful option, then the meeting will be held both in person at the Wayland Township Hall, 1060 129<sup>th</sup> Avenue and via electronic remote access.
