Wayland Township Board Meeting Minutes - 6:30 p.m. - November 1, 2021

Meeting was called to order at 6:30 p.m. by Supervisor VanVolkinburg.

Pledge of Allegiance was led by Trustee Stein

Roll Call: VanVolkinburg, McInerney, Miner & Stein; Kamyszek absent with notice.

<u>Approval of Minutes</u> from October 4, board meeting was motioned by Trustee Miner with support from Trustee Stein. All yes, motion carried.

<u>Audience Members</u> – Rachelle Smit candidate for State Representative introduced herself.

<u>County Commissioner Report</u> – Rick Cain not in attendance, discussed with VanVolkinburg that the redistricting of the County Commissioners will not be as previously reported and they will 'go back to the drawing board.'

<u>Planning Commission Report</u> – Miner shared discussions from the October 13, meeting. Dan Burrill from Grandview Estates returned and wants to move forward. They will provide more information and return on November 10, with a potential public hearing in December. Also discussed Marileigh Drive.

<u>Sheriff Deputy Report</u> – Deputy Baker reported no real major issues. Suicide calls have increased and be aware as car deer accidents are up considerably. Discussed Tyler Road previous issues and the ORV Ordinance. As so many roads in Wayland Township are exempted by the County, ORV riding hasn't been a problem.

<u>Cemetery Report</u>- Micah Kuhtic shared there were 10 burials in October. We have had 51 burials for the year, typical year is about 40 burials. Today, Wealthy Congdon; a wife of a Civil War Veteran was buried in West Elmwood Cemetery. McInerney worked with the Missing in America group out of the State of Washington and received her cremains 104 years following her death. Kuhtic will get the tree that is down in East Elmwood cut up. McInerney shared frustration with incorrect accounts receivable coming from Kubiak-Cook who was purchased by Dignity Memorial. Requested plow strobe light bid to submit with a grant request.
