An Ordinance to amend the Wayland Township Zoning Ordinance to revise the definitions of ‘family child care home’ and ‘group child care home’; to clarify how ‘family child care home’ and ‘group child care home’ are allowed within certain districts; to provide an effective date and to repeal all ordinances or parts of ordinances in conflict herewith.

**SECTION I**

**AMENDMENT TO CHAPTER 2, SECTION 2.06, DEFINITIONS “F”**

Chapter 2, Section 2.06 of the Wayland Township Zoning Ordinance is hereby amended to revise the definition of ‘Family Child Care Home’ to read as follows:

**SECTION 2.06 DEFINITIONS “F”**

*Family Child Care Home:* A dwelling unit in which increased capacity number of minor children permissible under State Law, are given care and supervision for periods less than 24 hours per day, operated by a person who permanently resides in the dwelling unit as a member of the household, and who is registered with the State of Michigan to provide such care.

**SECTION II**

**AMENDMENT TO CHAPTER 2, SECTION 2.07, DEFINITIONS “G”**

Chapter 2, Section 2.07 of the Wayland Township Zoning Ordinance is hereby amended to revise the definition of ‘Group Child Care Home’ to read as follows:

**SECTION 2.07 DEFINITIONS “G”**

*Group Child Care Home:* A dwelling unit in which minor children or such other increased capacity number of minor children permissible under State Law, are given care and supervision for periods less than 24 hours per day, operated by a person who permanently resides in the dwelling unit as a member of the household, and who is registered with the State of Michigan to provide such care.

**SECTION III**  
**AMENDMENT TO CHAPTER 4, SECTION 5.02, A AGRICULTURAL DISTRICT**

Chapter 4, Section 5.02 l) of the Wayland Township Zoning Ordinance is hereby amended to read as follows:

**SECTION 5.02 PERMITTED USES (A DISTRICT)**

l) Family Child Care Home

**SECTION IV**  
**AMENDMENT TO CHAPTER 4, SECTION 5.03, A AGRICULTURAL DISTRICT**

Chapter 4, Section 5.03 n) of the Wayland Township Zoning Ordinance is hereby amended to read as follows:

**SECTION 5.03 USES REQUIRING A SPECIAL USE PERMIT (A DISTRICT)**

n) Group Child Care Home per Section 18.09

**SECTION V**  
**AMENDMENT TO CHAPTER 4, SECTION 6.02, R-1 LOW DENSITY**  
**RESIDENTIAL DISTRICT**

Chapter 4, Section 6.02 f) of the Wayland Township Zoning Ordinance is hereby amended to read as follows:

**SECTION 6.02 PERMITTED USES (R-1 DISTRICT)**

f) Family Child Care Home

**SECTION VI**  
**AMENDMENT TO CHAPTER 4, SECTION 6.03, R-1 LOW DENSITY**  
**RESIDENTIAL DISTRICT**

Chapter 4, Section 6.03 d) of the Wayland Township Zoning Ordinance is hereby amended to read as follows:

**SECTION 6.03 USES REQUIRING A SPECIAL USE PERMIT (R-1 DISTRICT)**

d) Group Child Care Home per Section 18.09

**SECTION VII**  
**AMENDMENT TO CHAPTER 4, SECTION 8.02, R-3 MULTI-FAMILY**  
**RESIDENTIAL DISTRICT**

Chapter 4, Section 8.02 c) of the Wayland Township Zoning Ordinance is hereby amended to read as follows:

**SECTION 8.02 PERMITTED USES (R-3 DISTRICT)**

c) Family Child Care Home

**SECTION VIII**  
**AMENDMENT TO CHAPTER 4, SECTION 15.02, R-R RECREATIONAL RESORT**  
**RESIDENTIAL DISTRICT**

Chapter 4, Section 15.02 b) of the Wayland Township Zoning Ordinance is hereby amended to read as follows:

**SECTION 8.02 PERMITTED USES (R-R DISTRICT)**

b) Family Child Care Home

**SECTION IX**  
**SEVERABILITY**

The provisions of this Ordinance are declared to be severable. If any court of law shall hold that any section or provision hereof is invalid, such holdings shall not affect or impair the validity of any other section or provision of this Ordinance.

**SECTION X**  
**REPEAL**

All ordinances in conflict with this Ordinance are hereby repealed.

**SECTION XI**  
**EFFECTIVE DATE of Amendment @ Township Board Meeting**
