WAYLAND TOWNSHIP PLANNING COMMISSION MINUTES FOR THE MEETING ON 9-10-2025

- 1. MEETING CALLED TO ORDER: 6:30 p.m. by Vice Chairman Larry Brenner.
- 2. ROLL CALL: Ron DeVries, Deb Nardin, Jerry Ross, Larry Brenner, Rodney Standish, Matt Miner and Township Planner Rebecca Harvey.
- 3. ACCEPT AND/OR REVISE MINUTES: A motion to accept the minutes from 8-13-2025 was made by Ron DeVries, 2nd by Jerry Ross. All Aye, motion passed.
- 4. ACCEPT AND/OR REVISE AGENDA: A motion to accept the 9-10-2025 agenda was made by Ron DeVries, 2nd by Jerry Ross. All Aye, motion passed.
- 5. PUBLIC COMMENT #1: Collin Kummerfeldt stated that Blazing Star Solar will host an Open House on September 25th from 5 p.m. 7 p.m. at Sts. Cyril and Methodius Parish Hall.
- 6. NEW BUSINESS: Larry Brenner stated that Lillian DeKoning has resigned her position as Township Clerk and Bob Fryling is now serving as our new clerk. This, being an elected position, will be on the August 2026 ballot.
- 7. OLD BUSINESS: Battery Storage Facility Ordinance:
 - We reviewed the first draft of the ordinance created by Rebecca Harvey in August.

<u>Setbacks</u>: Jerry Ross questioned the minimum setbacks being far enough and Rebecca Harvey answered, "The setbacks are greater than PA233 requires and greater than the I-1 Industrial Zone district standards due to research and indicators for fire and explosions related to BESS facilities".

Sound: The draft ordinance reads: *The system may not generate a maximum sound in excess of 55 average hourly decibels as measured at the property line of an adjacent non-participating property.* Rebecca Harvey stated this is more restrictive than required by PA233.

<u>Decommissioning and Removal</u>: Surety Bonds and Decommissioning Bonds were compared and discussed as well as having the bonds reviewed yearly by the Planning Commission and approval by the Township Board.

<u>Fire and Emergency Response</u>: This commission has concern for the possibility of devastating fires and explosions at BESS facilities. Larry Brenner will meet with the Fire Chief for Wayland Township regarding safety, setbacks and Emergency Response Teams.

- 9. BUSINESS SECTON: Election of Chair and Vice-Chair positions.
